### **Enhanced Capital Allowance**

To endorse Ansell Lighting's credentials as a supplier of Energy Saving equipment, we are proud to have been approved by the Carbon Trust for the Energy Technology List, illustrated by our Authorised User No. 00841

Ansell are listed in the Technology category of Lighting, under the sub technology heading of HELU (High Efficiency Lighting Units).

Ansell luminaires are required to meet strict criteria governing the light output ratio of the luminaire and also, type of lamp used. Each luminaire is allocated an "F" rating to signify its efficiency, similar to the ratings seen on white goods, such as washing machines and fridges.

In addition to the energy saving benefits, end users are permitted to claim the value of equipment as an Enhanced Capital Allowance against their tax and may even be eligible for interest free loans from the Carbon Trust to assist initial purchase.

## **Waste Electrical Equipment Directive (WEEE)**

The Waste Electrical Electronic Equipment Directive (2002/96) is an EU legislative document that has been adopted into UK law. The directive can interpreted differently in each of the EU member states.

It deals with the collection and recycling of applicable products when they reach the end of their service life.

All Non-Household luminaires and Gas Discharge lamps are covered by the directive and products are identified by the crossed-out "wheelie bin" symbol.

Producers of equipment are issued with a unique code number, to show that they are registered with the appropriate authorities.

#### RoHS

The Restriction of Hazardous Substances Directive (2002/95/EC) is an article 95 directive, meaning it is consistent across all European Union member states.

Since July 1st 2006 the use of hazardous substances is restricted in products, to prevent damage to the environment.

The prohibited substances are Lead, Mercury, Cadmium, Hexavalent Chromium, Polybrominated Biphenyls and Polybrominated Diphenyl Ethers.
